Sector C

Sgt Preyer:

New Tampa – S/25-R (Residential Burglary)- 08-710813 @ 8900 Magnolia Chase Dr. grid 251 Occurred on 11/23/08 between 1200-2000 hours. Unknown suspect (s) unlawfully **entered an open garage** without permission and removed a bicycle valued at \$200.00 and fled undetected. Crime lab did not respond. Cpl. Schurig responded to the scene.

S/25-R 08-710709 (Residential Burglary) @ 10600 Liberty Bell Dr. grid 260 Occurred 11/20/08 - 11/21/08 between 1800-0700 hours. Unknown suspect (s) entered the residence, which is under construction, by unknown means (no forced entry found) without the owners permission. Suspect (s) removed from the garage a washer and dryer valued at \$1400.00 and fled undetected. Burglary was discovered on 11/21/08 but, the owner/construction company did not report the incident until 11/24/08. Therefore, crime lab did not respond to the scene.
