Sector C

Sgt Preyer: New Tampa

S-21 15425 Plantation Oaks Dr 2100-0700 08-743557 (Camden Live Oaks Apts) unk suspects entered the victims **UNLOCKED** car and stole a glass jar of coins (laundry money), Swiss Army pocket knife, and a Ipod docking station (no Ipod). There was no signs of forced entry. The vehicle was processed for prints with positive results.
