**Sector C**

**Sgt Preyer: New Tampa**

**Sig 21/25** (Vehicle Burglary & Home Burglary) 08 08-726187 8400 Dunham Station Dr (Grand Hamptons) 12/1-12/2 2300-0900 unk suspects entered the victims **UNLOCKED** 2008 Lexus. Once inside, suspects went through the pockets of her jacket which was on the front seat and discovered the CAR KEYS WITH ALARM. The suspects drove the car from its parking place and dumped it approx 1/2 mile away off of county line road (construction area) unk how long they had the car or how many miles they drove. Victim signed a sworn statement and the vehicle was processed for prints. Ofc Sloggett and Acosta are following up leads of possible juvenile suspects who live in area.(4 were arrested last week for sig 21/sig 25) Det. Bishop was notified via cell phone message. There was no damage to vehicle or items stolen from within the vehicle.
